Or the refuge would purchase it? A lot line adjustment could be done and it would protect that section.

Or even see if part of it could be a town forest. Thinking of generating income for the town. Lisa asked if the town is selling this to somebody and for what purpose. The purpose really matters. She said she could think of a lot of things that could go in there that would be bad. If something goes in there that is noise generating it could drive the wild life out.


Frank said he will get with Donald LaPlante to get an email drafted up to send to Katie Kopp at the WEDC to find out what the plan is. Lisa is going to help out.
